- 8) Send all 3 sheets (CP01, CP03 and 1259 form <u>INCLUDING A STAMPED SELF</u> <u>ADDRESSED ENVELOPE</u> to the Historic Plate Registrar, who will stamp and return the 1259 form for you to take to the RMS office with the registration renewal.
