



## 2021 ZESTINO TIRES NSW SUPERSPRINT CHAMPIONSHIP SUPPLEMENTARY REGULATIONS

### PART 2

#### 2.1 Two Competitions

These Supplementary Regulations are for a single event that includes two (2) competitions, which are a State Competition being a Round of the NSW State Supersprint Championship ("the Championship") and a Multi-Club Competition being a Multi-Club Supersprint ("the Multi-Club Supersprint"). All of the Supplementary Regulations apply equally to both competitions with the exception of those regulations that specifically state that they apply to just one or the other.

2.3 **Venue:** Wakefield Park

**Location:** Goulburn, NSW

2.4 **Promoter/Organising Club:** Mini Car Club of NSW

#### 2.6 Track

**Surface:** Bitumen / **Length:** 2.2kms / **Direction:** Clockwise / **Boundary:** Drivers who drive off the competition surface as defined by the solid line on the outer edge of the track with all 4 wheels will be deemed to have left the circuit and may have their lap times for that session forfeited.

#### 2.8 Drivers' Briefing

Drivers Briefing Notes will be available electronically to all Competitors, and a declaration that the Drivers Briefing Notes and Supplementary Regulations have been read is included in form SSP 06 *Disclaimer & Declaration* which is to be submitted electronically to the Event Secretary by no later than the Event Closing Date.

**Additionally, a compulsory Drivers Briefing covering key aspects of the day will be held at (time): 9:00am and (location): Adjacent to Control Tower..**

## 2.9 Number of Laps

Each run will comprise a **minimum time to allow all competitors to complete at least 3 timed laps**, with the time for the fastest single lap being used for results. **The minimum time for each run will be six Minutes.** The proposed **minimum number of runs on the day will be: 5**

(Note: The Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety reasons or if no competitors available)

## 2.10 Entries

- a) Maximum number of Driver entries for the Event: 108 Reserves: 5
- b) Maximum number of Drivers per car 2. Dual entry of drivers in Type 1 will be at the discretion of the organising club.
- c) Drivers must be a financial member of a Motorsport Australia Affiliated Car Club on the date of the Event and complete a declaration to that effect in the entry **Disclaimer form SSP 06 / 20/V1.**
- d) Vehicles competing in the NSW Supersprint Championship must either be currently road registered (incl. Historic & Classic) and/or be issued with a Motorsport Australia log book.
- e) Vehicles in the Multi Club Supersprint will not be eligible to score Championship points and must run under a competition number in the 900 – 999 range.
- f) Preferential Opening Date for Championship Registrants: 14<sup>th</sup> June 2021
- g) General Opening Date: 28<sup>th</sup> June 2021
- h) Entry Fee \$ 270
- i) Timing Transponder hire if required \$ 16.50
- j) Entry Closing Date: 21<sup>st</sup> July 2021 Late Entry Closing Date: 25<sup>th</sup> July 2021
- k) A Late Entry Fee of \$ 290 will apply for entries received after the Entry closing date.
- l) A pit usage fee of \$ 25 per garage .. will apply. Carports \$ 10 This to be arranged between the competitor and Wakefield Park .
- m) Entries will be accepted in order of receipt electronically together with the appropriate payment as required.
- n) Entries from Drivers between 14 and 18 years of age must have consent signed by a parent or legal guardian on the entry **Disclaimer form SSP 06 / 20/V1.**

## 2.11 Event Schedule

There will be no in-person document checks. Documents (Declarations etc) must be received electronically no later than two days after the Event Closing Date and will be checked prior to the event.

Drivers Briefing: 9:00am  
Event Start time: 9:30am  
**Event** Finish time: 4:00pm

## 2.12 Drivers Code of Conduct

Penalties for breaches of the Drivers Code of Conduct included in SSP 02 Sporting Regulations may apply.

## 2.13 Scrutineering

- a) There will be pre-event scrutineering at the Circuit of Multi Club vehicles described in clause 2.10 (e) above and of vehicles that are not registered to gain points in the State Championship. These vehicles will be allocated a competition number between 900 and 999.
- b) A self-scrutiny vehicle safety check must be performed using Self Scrutiny Checklist SSP 08 by all competitors whose vehicles do not have a Motorsport Australia Log Book.
- c) Vehicles that have a Motorsport Australia Log Book will be subject to the Targeted Scrutiny system.

**Forms SSP 08 / 20V2 Self Scrutiny Checklist (vehicles without log books) and SSP 07 / TSP03EE Self Statement of Vehicle Compliance (All vehicles) must completed, signed and SUBMITTED by email to Organisers no later than two days after the Event Closing Date.**

**Competitors must present themselves to Scrutineering with their Log Book and Proof of Vehicle Registration (as applicable) to have their Scrutineering windscreen sticker issued.**

*Please note that scrutineers may conduct checks through the day whilst maintaining distancing and non-contact protocols. If a non-compliance is found the Driver/Competitor may be referred to the Clerk of the Course.*

**2.14 Prizes / Awards (Multi Club Supersprint competitors not included)**

- a) Outright 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup>
- b) Zestino Trophy for 1<sup>st</sup> Place in Class (Championship only classes with 3 or more competitors).

**2.15 Medical Facilities:** Ambulance Service Australia; 1 ambulance, 2 Medical Personnel.

**2.16 Crash Rescue and Fire Fighting Facilities:** Wakefield Park Fire & Rescue

**2.17 COVID-19 Special Conditions**

- a) Under no circumstances may anyone attend an event if any of the following apply:
  - a. Have any symptoms consistent with COVID-19 such as higher temperature, respiratory issues, shortness of breath, sore throat, lack of sense of smell, fatigue
  - b. Been overseas in the previous 14 days
  - c. Been in contact with a known COVID-19 positive case in the previous 14 days
- b) Spectators are permitted.
- c) All attendees must check in using the Circuit's Service NSW QR Code app prior to venue entry.
- d) Sharing of tools, equipment and apparel is to be avoided. If sharing is unavoidable, the equipment must be cleaned prior to use by another person.
- e) The sharing of food is to be avoided.
- f) Social distancing as required by Governments is to be maintained.
- g) The COVID-19 Event Checker will be Laurelle Adlam.
- h) Comply with any requests by the COVID-19 Event Checker.
- i) Other conditions: None.

**2.18 Supplementary Regulations Part 1**

Supplementary Regulations provide information to competitors and drivers in addition to those which are contained in the Motorsport Australia National Competition Rules and the Motorsport Australia Manual. Part 1 of these Supplementary Regulations contains regulations that remain the same for each round this year. **2.19 Further Regulations:**

These Regulations have been updated from those issued 23<sup>rd</sup> May 2021. Item 2.11 has been updated with a revised Schedule. Event Opening time is now half an hour later due to Council noise restriction requirements.
