#### MINI CAR CLUB OF NSW NIRIMBA STATE CHAMPIONSHIP MOTORKHANA

#### 1. AUTHORITY

The Event will be conducted under the FIA International Sporting Code including Appendices, the National Competition Rules of Motorsport Australia (NCR), the Motorkhana Standing Regulations, the NSW Motorkhana Addendum, these Supplementary Regulations and any Further Regulations or instructions which may be issued. The Event will be conducted under and in accordance with Motorsport Australia OH&S, Safety 1st, Integrity and Legal, and Risk Management Policies, which can be found on the Motorsport Australia website at www.motorsport.org.au

#### 2. EVENT DESCRIPTION.

The Event will be Round 7 of the 2023 NSW Motorkhana Championship to be conducted at Nirimba TAFE, Eastern Road, Quakers Hill, on 23<sup>rd</sup> July 2023, on a sealed surface.

## 3. TESTS

Championship Events

Minimum of 6 Tests as per the Motorsport Australia Motorkhana Standing Regulations. There will be no reversing tests.

## 4. PROMOTER

The event will be promoted and organised by Mini Car Club of NSW.

## 8. JUDGES OF FACT

Timekeepers and observers will be Judges of Fact as detailed in the Motorkhana Standing Regulations. These names to be advised prior to the commencement of competition.

#### 10.START

The event is scheduled to start at 10am and will finish at approximately 4pm. Any changes will be notified in Further Regulations.

## 11.ENTRIES

Entries open on publication of these Regulations and close on 19<sup>th</sup> July. The entry fee is \$80, Juniors \$40.

Upon receipt of entries, the organisers will allocate competition numbers by class. Example: A1 to A10. B1 to B10, etc. This will assist in ensuring equal conditions amongst classes.

The entry form must be completed in full (available on Motorsport Australia Website – Permits- Speed/Non-Speed – Pre-event forms – Entry form, Speed/Non-Speed events) and accompanied by the entry fee and lodged with the event secretary.

Up to four drivers may compete in the one car, provided separate entries are lodged.

The event will be limited to 60 starters. In the event of more than this number of applications being received, preference will be given to order of receipt of entries.

The organisers reserve the right to refuse any entry in accordance with the provisions of the NCR.

#### 12.PARENTAL CONSENT.

If any entrant or driver is under 18 years of age, the consent of his/her parent or guardian must appear on the entry form.

## 13.LICENCES

Competitors must have a current and valid Speed/Speed Junior Competition Licence or superior, issued by Motorsport Australia, and Club Membership Card of a Motorsport Australia affiliated Car Club.

A valid Club membership card and a valid Motorsport Australia Speed/Speed Junior licence for this event must be presented at Document Check. This can be done electronically or in person.

Drivers must present vehicle Log Books (if issued) for stamping by the Chief Scrutineer.

#### 14.SCRUTINY

A self-scrutiny vehicle check must be performed by the competitor and driver using a Self-Scrutiny Checklist-Auto Test. The Self-Scrutiny Checklist form and the Event Entry Self-Scrutiny Statement of Vehicle Compliance (TSP03EE) scrutineering declaration must be completed, signed and emailed to the Event Secretary prior to the event. If, for some reason, this is not possible, contact the Event Secretary via email to discuss alternatives.

#### 15.SCRUTINY - SPECIAL RESTRICTIONS.

Motorkhana – Approved helmets in accordance with Schedule D of the Motorsport Australia Manual are to be worn in ALL specials. Apparel shall be in accordance with Schedule D of the Motorsport Australia Manual.

All vehicles must comply with Schedule A and Group 4H of the Motorsport Australia Manual. Cars must be adequately muffled to comply with noise restrictions. Fuel must be in accordance with Schedule G of the Motorsport Australia Manual.

**NOTE**: Electric vehicles (EVs) will not be permitted to be entered at this event, due to lack of officials' specific training and EV-specific safety equipment.

Any camera or video recording device mounted in or on a competition vehicle must be approved by the Chief Scrutineer.

#### 16.SAFETY

As per Schedule D of the Motorsport Australia Manual, adequate footwear must be worn by all drivers whilst competing (bare feet, thongs or sandals are not permitted).

Drivers of cars to which no windscreen is fitted must wear adequate eye protection whilst competing. All drivers shall, whilst competing, wear a properly adjusted seat belt, as per Schedule 1.

#### 17.DRIVERS BRIEFING

The Drivers Briefing will be held at 9:45am in the Pit Area. The briefing will be conducted using the Club's portable PA system.

#### 18.INSURANCE.

Certain public, property, professional indemnity and personal accident insurance is provided by Motorsport Australia in relation to the event. Further details can be found in the Motorsport Australia Insurance Handbook, available at <a href="https://www.motorsport.org.au">www.motorsport.org.au</a>.

#### 19.TIMING

Timing will be by means of electronic timing.

#### 20.ABANDONMENT

The Event Organiser reserves the right to abandon, postpone or stop the Event in accordance with the NCR.

#### 21.PROTESTS

Any protests must be lodged in accordance with the NCR. As far as possible, all judicial matters will be dealt with after the event by email or teleconference. Where a judicial matter must be dealt with on the day, social distancing will be observed.

#### 22.INTEGRITY, ALCOLHOL, DRUGS AND OTHER SUBSTANCES

Smoking (which includes e-cigarettes and "vaping") and any naked flame is prohibited within 3 metres of any refuelling/defueling operation.

Motorsport Australia's National Integrity Framework and any associated policy (including the Australian Anti-Doping Policy. Motorsport Australia's Illicit Drugs in Sport (Safety Testing) Policy, the Motorsport Australia Alcohol Policy), apply to any activity authorised by Motorsport Australia as published at <a href="https://www.motorsport.org.au">www.motorsport.org.au</a>.

Any Participant including the holder of a Motorsport Australia Licence (or a Licence issued by another ASN) may be tested for the presence of alcohol, any drug or other banned substance. In addition to any penalty imposed by Motorsport Australia, a further penalty/s may be applied by Sport Integrity Australia.

Consumption of alcohol in any Reserved Area is prohibited until all Competition is concluded each day.

#### 23. INSTRUCTIONS.

Failure to comply with any instruction given by an official of the meeting may result in the competitor concerned being excluded from the event by the Clerk of Course.

#### 24.CLASSES

Motorkhana Classes:

Class A – Production 2WD Vehicles Wheelbase up to 2150 mm

Class B – Production 2WD Vehicles Wheelbase 2151 to 2390mm

Class C – Production 2WD Vehicles Wheelbase 2391 to 2574mm

Class D – Production 2WD Vehicles Wheelbase 2575mm and over

Class E – 4WD vehicles (which must be driven in the four-wheel drive mode through the competition)

Class F – Front Wheel Drive Specials

Class G – Rear Wheel Drive Specials

Class H - Production Vehicle Based Specials

Non-production 4WS (4 Wheel steering) and 4WD vehicles are not permitted

Note: Group 4H Regulations prohibit 4WD in specials.

Motorkhana Categories:

(Nomination in a category does not preclude a driver from competing for class awards)

Category J – Juniors

Category LP – Ladies in Production Vehicles

Category LS - Ladies in Specials

**NOTE:** Competitors must nominate their classes prior to the start of competition. Any class which attracts less than three entries may be amalgamated with other class/es at the discretion of the organisers.

#### 25.VEHICLES

Vehicles must comply with Schedule A of the Motorsport Australia Manual, as well as the Regulations for Group 4H – Motorkhana Vehicles.

#### 26.AWARDS

Trophies will be awarded for -

1<sup>st</sup> Outright; 2<sup>nd</sup> Outright; 3<sup>rd</sup> Outright.

1<sup>st</sup> each Class

1<sup>st</sup> each Category

Best Mini Car Club Competitor

Results will be determined by the fastest time for each test.

NOTE: All awards are mutually exclusive.

## 27.PASSENGERS.

This event will include a Motor Sport Passengers Ride Activity (MSPRA) which shall be run under and in accordance with the Motorsport Australia MSPRA Policy.

#### 28.CATERING.

Food or drink will not be available for purchase at the ground.
